IN-PERSON CHURCH ACTIVITIES WILL RESUME IN JULY!!

Church leaders have discussed when the church could safely resume in-person worship and other church activities. Since most of our participating congregation is over the age of 65, we have decided to wait until July 5, three weeks after the beginning of Indiana's Phase 4 in lifting COVID-19 restrictions. The church must also prepare before we can meet again. **Here's how you can help:** 1) Drop off disinfectant cleaning supplies, and/or hand sanitizer at the church, 2) make reusable masks for worship participants, 3) Deliver exam gloves to the church. If you'd like to participate in getting the church ready but prefer to stay at home, please call the church and someone will come pick up the supplies you wish to donate.
